

Independent impairment assessments and reports (TAC requested) fees

Schedule of Medico Legal Fees for Independent Impairment Assessments

The fees below outline the fees payable for Independent Impairment Assessments that are requested by the TAC.

In response to COVID-19 the TAC introduced temporary funding of telehealth services to ensure clients can still access the treatments and services they need related to their transport accident.

Effective 1 July 2023

For Independent impairment assessments performed on or after 1 July 2023

For Independent impairment assessments performed between 1 July 2022 and 30 June 2023

| Examination and Report | IIA201 | Fee range \$1,576.91 to \$2,304.18 |
| Examination and report - Telehealth | IIA201T | Fee range \$1,576.91 to \$2,304.18 |
| Supplementary reports | IIA202 | \$492.77 |
| Client fails to attend examination | IIA203 | \$492.77 |
| Cancellation within 4 days of examination where examiner is unable to fill appointment | IIA204 | \$492.77 |

GST

* Item numbers denoted with an asterisk (*) include a 10% allowance for GST as TAC believes these are taxable supplies. If you are a provider and are **not registered for GST**, then the maximum claimable on these item numbers is 10/11ths of the corresponding Maximum Payment Rate. Providers who are not registered for GST are:

registered for GST are:

- Not legally permitted to charge GST; and
- Should indicate on all invoices submitted your status as 'not registered for GST'

A GST Registered provider **should not** add GST on top of the Maximum Payment Rate as an allowance for it is already included where applicable.

All other item numbers i.e. with no asterisk (*) are the Maximum Payments Rates regardless of whether you are registered for GST or not, as TAC believes these to be GST-Free supplies.
