



# TAC Club Participation Program 2025/2026 – Football Victoria

### **About**

The TAC Club Participation Program 2025/2026, delivered in partnership with Football Victoria, will award a prize pool valued at \$41,629.50 to Football Victoria-affiliated grassroots clubs that have actively promoted road safety within their club and community.

# **Prize Pool**

#### **Major Prize Pool**

Two (2) clubs will have the chance to win a major prize pool valued at \$5,000 (ex. GST) consisting of: \$5,000 voucher for Veto Sports.

#### **Minor Prize Pool**

Twenty (20) clubs will have the chance to win a total prize pool valued at \$1,000 consisting of: \$1,000 voucher for Mitre

#### Sign up incentive packs.

Fifty (50) clubs will win a TAC merchandise pack valued at \$232.59 RRP consisting of:

- Twelve (12) TAC branded drink bottle valued at \$137.02
- Twelve (12) TAC branded drawstring bags valued at \$39.47
- Twenty (20) TAC branded training cones valued at \$27.50
- Two (2) TAC branded whiteboard valued at \$12.76
- Twelve (12) TAC branded whiteboard magnets \$3.96
- Twelve (12) TAC branded exercise bands \$11.88

#### **Assessment Criteria**

## Major and minor prize pools

To be eligible for the prize pool, your club must submit a finalised application via the **SmartyGrants portal** and provide evidence of your activities against the key assessment criteria of the TAC Club Participation Program.

#### You are required to:

- Register your club via the SmartyGrants portal at: https://tac.smartygrants.com.au/tac\_cpp\_football
- 2. Complete all questions on the application form, addressing the assessment criteria as outlined in 2026-2026 TAC Club Participation Program Criteria:
  - How did your club and community get involved in promoting road safety?
  - How did your club participate in Road Safety Round?
  - Share the Road Safety Survey.
  - Provide photo or video evidence (uploaded via the same link) supporting each answer.
  - Include any other information that demonstrates your club's commitment to promoting road safety.
- 3. Submit your completed application by **5:00pm (AEDT), Sunday 31 May 2026**. Failure to follow the instructions above may result in your entry being disqualified. *Note: you may continually update your submission as many times as you like throughout the campaign period via the SmartyGrants portal.*







#### Sign up incentive pack

To be eligible for the incentive TAC merchandise pack, your club must:

- Be one of the first fifty (50) Football Victoria-affiliated clubs to register its details and application via the SmartyGrants portal; and
- Be able to provide evidence of your application number.

# **Evaluation & Judging Criteria**

Every application will be assessed by a panel comprising of key road safety and community experts from the TAC and Football Victoria.

Entries will be evaluated against the following criteria:

- 1. Club Eligibility confirmation that your club is a Football Victoria-affiliated club.
- 2. **Use of Assets** consistent and correct use of the provided digital collateral across social media, websites, newsletters, and/or display of physical printed posters within the club.
- 3. Communication effective and clear delivery of TAC road safety messaging.
- 4. **Evidence** Provision of photo or video evidence, supporting your submission.
- 5. Road Safety Round Participation active promotion and participation in Football Road Safety Round (13 April 26 April 2026).
- 6. **Independent Initiatives** implementation of additional initiatives that go above and beyond the provided collateral and assets to influence behaviour change within your club.

#### **Outcome**

A representative from Football Victoria will contact your club to advise whether your application has been successful during June 2026.
