

## **Occupational therapy fees**

#### Effective 1 July 2023

TAC has entered into a partnership with the <u>Victorian State-Wide Equipment Program</u> (SWEP). TAC uses this partnership to manage Occupational Therapist (OT) credentialing. OTs can bill the TAC at rates based on your SWEP credentials for the service type.

OTs not credentialed with SWEP can bill at the General OT / SWEP (Green/Amber) rate.

The TAC has extended the funding of temporary telehealth services previously scheduled to end on 30 September 2020 until further notice, giving clients the ongoing convenience and flexibility of accessing health services from home.

Occupational therapy services can be invoiced online via <u>HICAPS Digital Claims</u> for next business day payments.
